4. Manager's Report

- a. Financials
 - May-November presented
 - Lounge sales and Food sales are trending up and margins are within the acceptable range
 - New catering events have been booked for December and January, including an event for 230 people on December 29, 2024.
 - b. Membership
 - Final report for the season, membership is currently up approximately 9%
 - Rookie league will not continue in the new year. This will be looked at in the Strategic Planning session next Spring.
 - c. Information and discussion
 - The City of Lethbridge approved the redistribution of unused grant funding to give registered non-profit organizations in



Lethbridge the financial support to make a difference in the community. The Make Your Mark (MYM) grant was created. Will look into whether or not we may qualify for any additional grant money or if there is a program we could start for next season. The dealing to apply is March 31, 2025.

- So far only one team has declared their interest in registering for the Club Championships. We have until February 1 for any other teams to declare their interest. The club can register up to two Men's and two Ladies teams.
- Re-joined the Lethbridge Chamber of Commerce this month. This should be useful with the Catering/Retal side of the business. Will let the board know if there are any events that they may want to attend. Also planning for a Chamber meet and greet at the club in the new year.
- Still need volunteers for the Casino, January 3 & 4th. Shifts needed include Friday Day 2, Friday night 1, Saturday Day 2, and Saturday night 1.
- Added Spectrum Brewing Estrella Mexican Cervesa to the draft offerings. Spectrum is a local brewery.
- Cody Hall will be our USports/CCAA event ice maker. He is currently the Head Ice Maker at the Victoria Curling Club.
