- 1. Call to order at 5:29PM
- 2. Lethbridge is also home to the Metis Nation of Alberta, Region III.

- **4.** Approval of Minutes from January 18<sup>th</sup>, 2024 Approved by consensus.
- 5. Manager's Report Kirk Mearns
  - a. Total income is \$70000 over when compared to last year. Total gross profit of \$46000. Total expenses are up at \$42000.
  - b. Total income is down from previous year (-\$39000) due to Casino and COVID funds not on this year's books.
  - c. Payroll is higher half of this increase is in the lounge. This issue has been addressed with the supervisor and there will be an improvement in scheduling.
  - d. Kitchen margins are +3%; lounge margins are still down overall by 9% but we are back to over 60% monthly.
  - e. Financially Kirk feels the season is in good shape.

Shirtsleeve Bonspiel and JC Bonspiel results will be next month. All indications are that they both did very well.

Currently 15 teams are registered for the last chance bonspiel. Last year there were 24 teams. Kirk will follow up with some of last year's teams this week.



U15 Triples are going ahead on Sunday, March 3<sup>rd</sup>. Six teams are registered.

Nick and Kirk met with the city of Feb 13<sup>th</sup> (their request) The purpose of this meeting was to discuss our summer hours. We will also give them an updated renovation schedule.

Curling Alberta fees are increasing by \$4 for 2024/2025. This increase is 21% over the previous year fees.

- a. Nanette and Daniel discussed paper inventory look at expensing this out in the future, as itemizing the paper inventory would be labour intensive.
- b. Club is in a strong position financially.

- $\circ~$  The board had previously approved a \$125000 budget for the renovation.
- Moved by Ryan, seconded by Dave, that the Lethbridge Curling Club Board of Directors increase the budgeted spending limit, for the renovation project, previously approved, to \$250000. APPROVED.
- Email from Curling Canada (Danny Lamoureux) about the possibility of hosting the National University/College.
- Moved by Daniel, seconded by Lynne, that we pursue hosting the National Canadian University/College Championships in February 2025. APPROVED.
- November 2025 Canadian Club Championship we have a pending bid.



- Discussion around hosting several other events in 2025 and 2026. It would be ambitious however going to the City of Lethbridge with a list of packaged events may facilitate the request for funds.
- Moved by Daniel, seconded by Lynne, that Lethbridge Curling Club Board of Directors direct our management committee to pursue hosting Curling Alberta Men's and Women's Provincial Championships in January 2026 and the Curling Canada Scotts Tournament of Hearts in January/February 2026. APPROVED.
