 - Financials
 - *May December presented*
 - Revenues are up in Memberships, Lounge, Kitchen, Ice Rentals, and League Rentals. Proshop is lagging slightly. Overall revenues are up
 - Expenses are up slightly in the Lounge and Payroll
 - Administration expenses are up due to paying some expenses a month earlier than last year
 - Profits are up
 - Catering is up approximately \$10K. Catering demand is high. Will be looking at purchasing additional dishes and other items rather than renting them. Will also look at purchased 3-4 additional round tables with chairs using funds from the renovation budget.
