 - Revenue collected by Curling I/O and not deposited.
 - Membership numbers only reflect those members paying the membership fee. Life Members, Juniors, Rental Leagues, Corporate League and High School players are not included.



- Tuesday Men and Wednesday open full. Thursday Open and Monday Open will be minimum of 20 teams each. There were some double registered teams in both Monday and Thursday and we had 1 team pull out of Monday. All other leagues filling normally.
- We are working on getting some players put together for teams.
